Eligibility Criteria	<ul style="list-style-type: none">Lead bidder must be a company registered in Sri Lanka involved in the payment card industry and having a business relationship with an overseas principal card manufacturer.Lead bidder should have supplied a minimum of 250,000 EMV cards in Sri Lanka during the period from 2023 to 2025.The principal card manufacturer should have supplied more than 20,000,000 EMV cards globally during the period from 2023 to 2025.The Personalization facility of the Principal Card Manufacturer must be PCI-CP Certified and must provide a document describing the security measures pertaining to handling Security Keys and Cards and data files with Clear Card Numbers*.The relationship between Lead Bidder and Principle should be of minimum 1 year from date of Document / tender publishing date.The Lead bidder should not have been blacklisted by any Sri Lankan Bank at the time of Bid submission.The Lead bidder should supply card from VISA, MasterCard certified card manufacturer only. <p><i>*Documentation evidence needs to be produced</i></p>

1. It is mandatory for any person, who acts as an agent or sub agent, representative or nominee for and or on behalf of any tenderer, shall register himself and such public contract as per the Public Contract Act, No. 03 of 1987, before applying for the tender.
2. Bid Documents could be obtained from the Supplies Manager, Supplies Division, National Savings Bank, No. 255, Galle Road, Colombo 03. Tender forms will be issued from 03/09/2025 between 8.30 a.m. and 3.00 p.m. on working days till 24/09/2025 on submission of a written request.
3. Perfected bidding documents should be accompanied by a Bank Guarantee / Bid Bond acceptable to National Savings Bank for the value relevant to the tender as indicated above and issued by a commercial bank and valid for a minimum period of 119 calendar days from the date of opening of the Tender.
4. Bids with duplicate shall be deposited in the tender box available at **Supplies Division, National Savings Bank, 255, Galle Road, Colombo 03**. On or before 10.00 am on 25/09/2025. Bids will be opened immediately after closing of the bids. Bidder or his authorized representative will be permitted to be present at the time of opening of bids.

5. National Savings Bank reserves the right to accept or reject any or all Bids and the right of accepting any portion of a bid received without assigning any reason.
