1. Eligibility Criteria:

- i. Bidder shall not have been blacklisted by the Government of Sri Lanka or by the Bank.
- ii. The bidder must not be listed in the List of Defaulting Contractors of the Government of Sri Lanka, the National Savings Bank, or any Statutory Government Corporation or Board.
- iii. The bidder should have at least 2 years of experience in Supplying 500 End Point Licenses and providing support services.
- iv. The vendor must have successfully completed at least one installation of 500 End Point Licenses for financial institutions in Sri Lanka
- v. The bidder should not have a conflict of interest relating to the business domain of the Bank within Sri Lanka
- vi. They should possess the Certificate of Business Registration issued by the Governmental Authority.

In addition to the basic eligibility criteria, the Bidder should satisfy the criteria mentioned in the Bidding Document.

2. The bidder must be registered for the particular bid under the “public contract Act. No 3 of 1987 at registrar of companies” office and submit PCA 03 form with the bid.
3. Bid Documents could be obtained from the Supplies Manager, Supplies Division, National Savings Bank, No. 255, Galle Road, Colombo 03. Tender forms will be issued **from 01/09/2026 between 8.30 a.m. and 3.00 p.m. on working days till 21/09/2026** on submission of a written request.
4. Bids will be opened immediately after closing at **10.00 a.m. on 22/09/2026** and the bids received after 10.00 a.m. will be rejected and returned unopened.
5. National Savings Bank reserves the right to reject any or all bids and the right to accept any portion of a bid without adducing any reasons.
